Mr. Joyce has over 26 years of engineering experience in the field of wastewater odor and corrosion control and has pioneered the use of biological and other cost-effective odor control methods. Mr. Joyce holds bachelor's degrees in Biology, Chemistry and Civil Engineering and a Master's Degree in Environmental Engineering from Virginia Tech. He has authored numerous articles and publications on the subject of municipal odor and corrosion control and was a Principal Author of Manual of Practice No. 22 (1995) "Odor Control in Wastewater Treatment Plants" and Author of ASCE Manual of Practice No. 82 "Odors and Air Emissions from Wastewater Treatment Plants, published jointly by the Water Environment Federation and American Society of Civil Engineers. He has presented numerous seminars and lectured widely on the subject of odor and corrosion control. He is a member of the Water Environment Federation Odor Control Committee, Past President of the Southeast Section Water Environment Association of Texas and is immediate Past President of the Water Environment Association of Texas. He is currently serving as one of two representatives from the United States on the IAWQ Sewer Solids and Process Work Group Committee studying the biological and physical sewer relationships of odor generation. Mr. Joyce is a recognized authority on sewer ventilation and specializes in large diameter and deep tunnel sewer odor and corrosion investigation
