WEAT, with assistance from TCEQ, has developed this Fats, Roots, Oils and Grease (FROG) Workshop to provide utilities approaches to help develop new or modify existing FROG prevention and control programs in order to reduce the amount of FROG entering collection systems. Reducing FROG can help reduce sanitary sewer overflows and impacts on wastewater treatment plants. Experts will present information and facilitate discussions on a variety of topics included below to help utilities get the most out of their FROG program.
